

Turistic Privacy Policy

INFORMATION AND CONSENT

Under Article. 13 and 23, D. lgs. 196 of 30 June 2003

To comply with the law on privacy We inform you about your personal information and their rights.

Under D.lgs. No 196/2003 (Code for the protection of personal data), which replaced Law No. 675/1996, processing information that the deal will be based on the principles of fairness, transparency and protection of your privacy and your rights.

We ask then to give consent for the processing of data needed for operations and services you have requested. This consensus also, more specifically, the work done by other players in the field of tourism or the development of the territory of Puglia. These companies are our employees and play the role of "controller" of our data processing, or work in full and total autonomy as a separate "owners" of treatment. It is, in particular, companies that perform services for holiday home, hotel management and administration of real estate for third parties, freight transport means and pleasure craft, hiring of tourist facilities in general, management of beaches, restaurants, Retail sales of organic food, wine shops, bars, wine and olive farms, cleaning services, linen supply, laundry, provision of service personnel (chef, domestic, baby sitter, hairdressers, beauticians and so on.) diving excursions, fishing tourism, trekking, guided tours.

There is currently no list of subjects that will be communicated its data because we have not yet closely with their trade agreements. Before that time (to be published on the website of the list of persons entitled to treatment), your data will be handled solely by Barbarhouse & Co. s.n.c.

The treatment will be made through paper mode and / or computerized;

The provision of data of full name, address, telephone number, e-mail address is required in order to be able to provide the services required and any refusal to provide such data could result in failure or partial performance of service provided;

The processing of data takes place at the premises and at the premises of facilities contacted, and will be furnished only by staff entrusted to it.

You can exercise your rights with the treatment, according to art. 7 of the Code of privacy (formerly art. 13 of Law No. 675/1996), in particular, you can request information regarding the existence of processing data that may affect them; to achieve without delay a communication in intelligible form of the data and their origins, the cancellation, transformation in anonymous form or block of data processed in violation of the law, updating, rectification or the integration of data; certification that the above transactions were brought to the attention of those that the data were disclosed, except where this proves impossible or involves a manifestly disproportionate to the protected right; to object, in whole or in part, for legitimate reasons, the processing of personal data The concern, even if relevant to the purpose of the collection;

The data you voluntarily provide will be used, within the limits of privacy, for the following purposes: to provide information on the territory Pugliese, provide information on the proposals receptive published on the portal, providing information about the activities carried on by other players in the field tourism or the development of the territory of Puglia.

In any case, neither we nor our society direct employees deal with "sensitive data" (1).

The information you provide is used only with terms and procedures necessary to provide the services you want (2) even when we communicate to that end some of these data to other players in the field of tourism or the development of the territory of Puglia.

Without its data can not supply the services in whole or in part. Some data, then, must be disclosed by you or by others for legal obligations. (3)

She has the right to know, at all times, what are your data and how they are used (4). He, too, the right to update, integrate, correct or delete, call blocking and object to their treatment.

For all this, please contact the On-site processing of personal data to the address above.

You can freely decide whether to give your consent to Barbarhouse & Co. s.n.c for the use of your data. Giving consent it will be freely given to activities not closely related to the services requested by you, but help improve them and to know the new services offered by Barbarhouse and other companies.

In particular, you with your consent to allow Barbarhouse & Co. s.n.c to use your data for:

a)

communicating to companies that collect on behalf of Barbarhouse & Co. snc the quality of services or the needs of customers;

b)

for promotions cured solely by Barbarhouse & Co. snc through the use of newsletters telephone, SMS, sending brochures or printed material and other instruments;

for sales promotions of products and services of others.

If no agreement to Barbarhouse & Co. s.n.c. to use your data to communicate to companies that collect on behalf of the company Barbarhouse & Co. s.n.c. service quality or customer needs should notify the Barbarhouse & Co. s.n.c. by registered mail, e-mail or fax.

If, however was not interested in promotions cured solely by Barbarhouse & Co. s.n.c. through the use of newsletters, phone calls, SMS, sending brochures or printed material and other instruments and promotional products and services to other companies or were not interested in the newsletter will be enough to click at the bottom of the newsletter on the item or unsubscribe Otherwise, contact your system administrator at info@perledipuglia.it.

(1) shall be considered sensitive data, the data fit to reveal the racial and ethnic origin, religious belief, philosophical or otherwise, political opinions, membership of political parties, unions, associations and organizations of religious , Philosophical, political or trade union, nor personal data to reveal the state of health and sex life, those related to health (Article 4, co.1, d. Legislative Decree No 196/2003).

(2) eg. mandates for the management and administration of real estate for contractors, rental contracts and sub rent voucher for a reservation, lease contracts and so on tourism.

(3) Think for example. the data necessary to fulfill tax obligations (eg. billing).

(4) These rights are stipulated in art. 7 of Legislative Decree. No 196/2003. Cancellations and blocking concern processed data in violation of the law. The need for integration has an interest. The right of opposition may be exercised in respect of material and commercial advertising, direct sale or market research. In other cases, the opposition requires a legitimate reason.
